## 3. Type of personal data collected

---

We process the following personal data that we receive from you as part of our business relationship:

- Surname and first name
- Date and place of birth
- Address
- Contact details
- IT usage data if you log in to the ANF network
- Optical video recordings of the company premises, including the entrance and the immediately adjacent outdoor area (sound recording does not take place), and
- Date and time of recording

## 4. Processing purposes and legal basis

---

The processing of your personal data is necessary for the performance of the contract with you as a business partner, Article 6 para 1 lit.b GDPR.

ANF GmbH processes the personal data for the purpose of documenting your activity for the legitimate interest of ANF GmbH, in consideration of your personal rights.

Furthermore, the data is processed by ANF GmbH in order to avoid unauthorized access to the premises in accordance with Article 32 GDPR.

Recording data from the video surveillance systems are processed on the one hand to prove the guarantee of safe production processes and on the other hand to document and clarify any criminal acts and to exercise the property rights.

The collection, processing and use of your data in connection with the documentation of your activity on the premises or on the site of ANF GmbH or its subsidiaries on the basis of Article 6 paragraph 1 sentence 1 letter f GDPR.

## 5. Recipients of your data

---

### 5.1 Within our home

Your data remains with Advanced Nuclear Fuels GmbH. Internal recipients are employees of the plant security, employees of the human resources department (HR), employees of the specific department cooperating with you as a business partner and, if applicable, employees of the accountancy department. In addition, our company data protection officer has access to your data as an external entity. The recordings of the video surveillance equipment can also be viewed by the central technical department.

### 5.2 In the context of order processing

Your data may be passed on to service providers who work for us as contract processors:

- Support or maintenance of IT systems and applications
- Payroll accounting

### 5.3 Other third parties

Data is passed on to recipients outside of our company in compliance with applicable data protection regulations, for example, to public authorities and institutions (e.g., financial or law enforcement authorities) in the event of a legal or official obligation.

## 6. Duration of storage of your data

---

Your personal data will be deleted if the intended purpose is omitted and if there are no other retention periods for it.

Your data, which is recorded as part of video surveillance, will be deleted 72 hours after recording. A longer storage is only carried out if the records are still needed longer for clarification or to prove a specific incident. In this case, the data will be blocked and immediately deleted after the full completion of the clarification measures or after the requirement for proof has ceased.

## 7. Your privacy rights

---

You have the right to information pursuant to Article 15 GDPR, the right to rectification pursuant to Article 16 GDPR, the right to erasure pursuant to Article 17 GDPR, the right to restrict processing pursuant to Article 18 GDPR and the right to data portability pursuant to Article 20 GDPR.

In accordance with this provision, you also have the right to object to the processing of your data under Article 21 GDPR. Please address such concerns to data protection officer [datenschutzbeauftragter@framatome.com](mailto:datenschutzbeauftragter@framatome.com)

The right to information and the right to erasure may be subject to restrictions pursuant to section 34 and section 35 of the German Federal Data Protection Act.

## 8. Your right for complaint with a supervisory authority

---

You can at any time lodge a complaint with the competent data protection supervisory authority, for example at your place of residence, your workplace or at the place of the alleged violation, in accordance with Art. 77 GDPR.
