With the following information, we would like to give you an overview of the processing of your personal data and your resulting rights. Which data is processed in detail and in which way your data is used depends largely on the respective requested or agreed services. Therefore, not all statements contained herein may apply to you.

## 3. Type of personal data collected

---

We process the following personal data that we receive from you as part of our business relationship:

- Surname and first name
- Contact details of visitors
- Optical video recordings of the company premises, including the entrance and the immediately adjacent outdoor area (sound recording does not take place), and
- Date and time of recording

## 4. Processing purposes and legal basis

---

At Advanced Nuclear Fuels GmbH, the personal data is processed for the documentation of your visit for legitimate interest by Advanced Nuclear Fuels GmbH, in consideration of your personal rights.

Furthermore, in order to avoid unauthorised access to the premises, the data is processed by Advanced Nuclear Fuels GmbH in accordance with Art. 32 GDPR processed.

Recording data from the video surveillance systems are processed on the one hand to prove the guarantee of safe production processes and on the other hand to document and clarify any criminal acts and to exercise the property rights.

The collection, processing and use of your data in connection with the documentation of your visit is carried out on the basis of Article 6 para. f GDPR.

## 5. Recipients of your data

---

### 5.1 Recipients of your data within our company

Your data remains with Advanced Nuclear Fuels GmbH and internal recipients are employees of plant security and access management.

### 5.2 Recipients of your data outside our company in the context of order processing

Your data may be passed on to service providers who work for us as contract processors:

- Secova (operator of SAM, software necessary to carry out training)
- Employees of the plant security / reception

## 5.3 Other third parties

Data is passed on to recipients outside of our company in compliance with applicable data protection regulations, for example to public authorities and institutions (financial, law enforcement and reliability inspection authorities, etc.) in the event of a legal or official obligation.

## 6. Duration of storage of your data

---

Your personal data will be deleted if the purpose is no longer applicable. Storage is only carried out if the records are still needed longer for clarification or to prove a specific incident.

## 7. Your data protection rights

---

You have the right to information pursuant to Article 15 GDPR, the right to rectification pursuant to Article 16 GDPR, the right to erasure pursuant to Article 17 GDPR, the right to restrict processing pursuant to Article 18 GDPR and the right to data portability pursuant to Article 20 GDPR. In accordance with this provision, you also have the right to object to the processing of your data under Article 21 GDPR.

## 8. Your right to complaint with a supervisory authority

You can at any time lodge a complaint with the responsible data protection supervisory authority, for example at your place of residence, your workplace or at the place of the alleged violation, in accordance with Art. 77 GDPR.
